



ORIENTAL TOWN BOARD MONTHLY MEETING

1 The Town Board of Oriental Regular monthly meeting was held on Tuesday, August 2, 2022 was called to order at  
2 8:01 AM. Mayor Pro Tempore White determined a quorum to be present, opened the meeting and turned it over to  
3 the Manager. The meeting was open to the public. All documents for the meeting were available through the

6 Present: Mayor Pro Tempore White, Commissioner Overcash, Commissioner Price, Commissioner Winfrey,  
7 Commissioner Roe, Town Manager Diane Miller, Administrative Assistant Cyndi Brann, and several members of  
8 the public. Absent was Mayor Belangia,  
9  
10 Approval of Agenda: Commissioner Roe made a MOTION to accept the agenda. Commissioner Winfrey seconds.  
11 5-0.  
12 Consent Agenda: Commissioner Roe made a MOTION to approve the consent agenda. Commissioner Overcash  
13 seconds. 5-0.  
14  
15 Public Comment: BCandy Bohmert (representing the Ol Front Porch Music Festival) 8:03AM. Ms. Bohmert  
16 requests same street closings for the festival/Church St one-way, and electricity on boards X 3.  
17  
18 Local Water Supply Plan Resolution: NCDENR requires that the LWSP filed is approved by the Board.  
19 Commissioner Overcash makes a MOTION to approve the LWSP. Commissioner Roe seconds. 5-0.  
20  
21 ECCOG Member representative: At the organizational meeting, the Board decided Commissioner Price be the  
22 representative to the Council. The Board can either stay with that or appoint new. Commissioner Overcash makes a  
23 MOTION to appoint Commissioner Price as Oriental's representative to the ECCOG. Commissioner Winfrey  
24 seconds. 5-0.  
25  
26 Budget Amendment #1: Budget Amendment accounts for final totals in establishing Capital Reserve. Commissioner  
27 Overcash makes a MOTION to approve the budget amendment as presented. Commissioner Winfrey seconds. 5-0  
28  
29 Capital Reserve Ordinance: The Board establishes Capital Reserve in both Police and Public Works to save for  
30 equipment. Manager explains the length and contribution can be changed by a future Board. Mayor Pro Tempore  
31 White makes a MOTION to accept the Capital Reserve Ordinance as presented. Commissioner Overcash seconds.  
32 5-0.  
33  
34 Resolution 2022-05: Resolution congratulating Oriental United Methodist Church for 125 th Anniversary in  
35 Oriental. Commissioner Roe makes a MOTION to approve the resolution. Commissioner Overcash seconds. 5-0.  
36  
37 Net House Bid award: After receiving 10 no-bids, we have a current bid for the restoration of the Net House. In the  
38 budget, the Board provided \$65000+ for the project and rock replenishment at the end of Wall St. When those are  
39 exhausted, the Board will see a budget amendment to provide additional funds from the Harbor reserve.  
40 Commissioner Overcash makes a MOTION to accept the bid on the Net House. Commissioner Roe seconds. 5-0.

42 Police Report- Both June and July. Officer Wichrowski was present to give the report. Brief discussion of  
43 movement of speed sign.

45 Manager's Report: Included. Ms. Crosser, recognized by Mayor Pro Tempore White asks if HWAC and Tourism  
46 can be broken down by expenses. Manager notes that is available at any time from the office. As restricted  
47 accounts, there are very specific expenses they can be used for. Manager asks Board to be prepared to choose topics  
48 for Sept 29 quarterly meeting.
